ORDINANCE 2020 - 6

WHEREAS, the Town of Monroe, County of Adams, State of Indiana, (the "Town") has received a request from the Adams Central School Corporation (the "School") to dedicate an alley as one-way during the school year in order to promote public safety;

WHEREAS, the Town has jurisdiction over the alley and desires to dedicate the alley as a one-way thoroughfare during the regular school year;

WHEREAS, the Town will cause to be erected signs that apprise and inform the public of the limited one-way dedication of the alley;

WHEREAS, the Town Marshall shall have authority to enforce this ordinance for any vehicles that violate the terms contained in this ordinance;

NOW THEREFORE, the Town Board for the Town of Monroe, County of Adams, State of Indiana, hereby ordains and adopts the following ordinance:

Section 1. Purpose. The purpose of this ordinance is to promote the public safety, and, more specifically, to promote the vehicular flow of traffic to and from the School by dedication of the alley as a limited one-way thoroughfare during the regular school year.

Section 2. Terms. The terms used in this Ordinance shall have the meanings defined herein and are not intended to be used in other ordinances adopted by the Town unless express reference is made to this ordinance.

- A. "Alley" shall mean the roadway that runs East and West and lies North of Indiana State Road 124 commencing at North Polk Street and running West for a distance of approximately Six Hundred Eighty-Five (685) feet terminating at the East boundary of the Adams Central Community School Corporation property.
- B. "One-Way" shall mean the following: the Alley shall be dedicated to East bound vehicular traffic from: (i) seven o'clock (7:00) AM until eight fifteen o'clock (8:15) AM; and, (ii) two o'clock (2:00) PM until three fifteen o'clock (3:15) pm on Monday through Friday during the regular school year.

Section 3. Signage. The Town shall erect signage that designates the Alley as One-Way for East bound vehicular traffic from: (i) seven o'clock (7:00) AM until eight fifteen o'clock (8:15) AM; and, (ii) two o'clock 2:00 PM until three fifteen

o'clock (3:15) PM, Monday through Friday, during the regular school year for the School. Signage shall specifically state that violators will be cited for violation of this ordinance and subject to a fine per each violation as set forth in Section 4 below herein.

Section 4. Violations. Any person operating a vehicle who enters the Alley and travels West on the Alley during the times the Alley is dedicated as One-Way for East bound traffic shall violate this ordinance and be subject to the following schedule of fines:

First Offense:	Fine of up to Fifty and 00/100 Dollars (\$50.00);
Second Offense:	Fine of up to One Hundred and 00/100 Dollars (\$100.00);
Third Offense:	Fine of up to Two Hundred Fifty and 00/100 Dollars (\$250.00); and,
Additional Offenses:	Minimum fine of Two Hundred Fifty and 00/100 Dollars (\$250.00).

The Town of Monroe, County of Adams, State of Indiana, Marshall, and the Adams County Sheriff shall issue citations to all violators and jurisdiction for said violations shall be proper in the Adams Superior Court.

Section 5. Effective Date. This Ordinance shall become effective upon (i) its adoption and (ii) the erection of the signage as described in Section 3 above-herein.


